on Thursdays from 10:00am to 1:00pm.

Trained staff and volunteers will answer this line and all eligible clients will speak with a Her Justice attorney that same day. (Immigration issues are handled through Family Justice Centers only.)

WHAT KIND OF HELP DO YOU NEED?

We can help you:


- start a divorce action
- seek an order of protection from family court
- request child and/or spousal support
- pursue custody of your children and/or a visitation schedule
- request legal immigration status for yourself and your children if you qualify based on a history of intimate partner violence

Depending on your situation, we can provide you with:

- answers to questions about the law and the court system, especially if you are representing yourself
- one-time assistance preparing legal documents that are required for your case
- a volunteer attorney who will represent you in court free of charge

To use Her Justice services, you need to:

- identify as a woman
- live in the Bronx, Brooklyn, Manhattan, Queens, or Staten Island, or have an open family court or divorce case in New York City
- have a legal issue relating to family, divorce or immigration law
- meet our income guidelines

➤ By phone:

You can call our live Legal Help Line at 718.562.8181 on Thursdays from 10:00am to 1:00pm (with the exception of immigration issues which are only handled through Family Justice Centers). Trained staff and volunteers will answer this line and all eligible clients will speak with a Her Justice attorney that same day.

Our staff is multilingual and will assess your case to ensure that we can provide the appropriate services.

➤ In person at a Family Justice Center:

Her Justice is an onsite partner with offices at all five of the New York Family Justice Centers – Bronx, Brooklyn, Manhattan, Queens and Staten Island.

To qualify for services at Family Justice Centers, you must be a current or past victim of intimate partner or elder abuse and either live in the borough where the center is located or have been abused in that borough.
