### *Her Justice Summer Associate Program: Provide Hands-On Legal Experience to Summer Associates*

Through the Her Justice Summer Associate Program (SAP), Summer Associates at Corporate Partner law firms gain hands-on legal experience in litigated and non-litigated cases. Trained intensively and then mentored by the Her Justice legal team, Summer Associates are assigned clients, build attorney-client relationships, draft and file pleadings, motions, affidavits and immigration petitions, negotiate with opposing counsel, interact with court personnel, and develop critical legal skills and confidence.

### *Her Justice Clinic Program: Engage a Corporate Client and Associates in Pro Bono Work*
