#### Her Justice Advocacy Leads to a Nationwide Policy Win

Thanks to the advocacy of Her Justice and other organizations across the nation, the United States Citizenship and Immigration Services (USCIS) has issued new fee regulations that include fee exemptions for virtually all immigration applications based on claims of gender-based violence.

What does this mean? As of April 1st, Her Justice clients no longer have to worry about paying any immigration application fees or applying for fee waivers in order to request immigration status. This is a meaningful win, as fees are often impossible for our clients and applying for fee waivers takes time and they are not always approved.

#### Her Justice Brings Our Original Policy Report to Washington, D.C.

In April, Director of Policy Rachel Braunstein shared findings from our policy report <u>Stories</u> <u>from Immigrant Survivors of Gender-Based Violence: The Impact of Work</u> <u>Authorization</u> with lawmakers in DC. We were thrilled to educate and collaborate with policymakers and their staff about the need for expedited work permits for immigrant survivors of gender-based violence.

Our team highlighted the power of work authorization to significantly improve financial independence, housing stability, confidence to seek help from law enforcement and the justice system, and health and well-being. We shared our clients' stories about the impact of delays in obtaining work authorization – with some waiting five years or more after applying while they work and raise families in New York City, where many have lived for decades – and the life-changing relief from being approved.

### **Policy Developments to Watch**

SCOTUS Upholds Federal Law Keeping Guns Out of the Hands of Abusers We're relieved to share that this past Friday, the Supreme Court made the decision to

maintain a decades-old federal ban on gun possession when a restraining order is in effect. This case was sparked by the Supreme Court's 2022 ruling in New York State Rifle & Pistol Association v. Bruen, which said courts must judge restrictions on gun rights by turning to early American history as a guide. Given that context, we're relieved at the outcome of U.S. v. Rahimi. #### State Bill Drafted by Her Justice Passes in Senate

For the past several years, Her Justice, along with a coalition of other advocates in New York City, has helped to draft and advocate for a State bill (S.2278-A, Cleare/A.1309-B, Rosenthal) designed to provide relief from "coerced debt" to survivors of domestic violence, elder abuse, human trafficking, and abuse by caretakers. The proposed legislation would amend New York State law to prohibit creditors from collecting a consumer debt incurred because of economic abuse and fraud and to allow the survivor to sue in court for relief against creditors. We made a big push for the legislation this cycle and were excited to end the session with Senate passage! We will continue our advocacy next year with the goal of passing in the Assembly.

This policy solution matters because many of our clients experience financial abuse. This happens when one intimate partner controls the other's access to economic resources. It diminishes the victim's capacity to support themselves and forces them to depend financially on the abuser. Debt and damaged credit as a result of financial abuse (which can look like withholding assets, identity theft, or debt incurred without consent) make it even more difficult for survivors to leave the relationship – for example, with a low credit score, survivors cannot rent an apartment, get a job, or buy a house or car. Here's to passing this important legislation next cycle!

#### State Bill Introduced to Protect IOLA Fund Against Future Sweeps

The Interest On Lawyers Account (IOLA) Fund is one of the top funders for civil legal services in New York State. Her Justice and our many community partners depend on IOLA funding to support our clients. This year, \$55 million was diverted away from the fund into the general State budget. This was after the legal community staved off an unprecedented proposal to sweep \$100 million away at the beginning of the year.

In response, Senator Sean Ryan and Assembly Member Michaelle Solages have introduced legislation that would remove the IOLA Fund from the appropriations and budget process. This will ensure that last month's diversion of IOLA revenue into the State budget will be a one-time event and protects the mission of the IOLA Fund: to support civil legal services for low-income New Yorkers. **READ ABOUT THE BILL HERE** >

## Her Justice Trains Newly Appointed Family Court Judges on the Court's Power in Addressing Family Violence

Family & Matrimonial Practice Director Anna Maria Diamanti trained all newly appointed family court judges as part of the NY State Judicial Institute. She covered Article 8 (orders of protection) proceedings, as well as common dynamics of domestic violence, the impact of trauma, myths and assumptions about victims and perpetrators, and firearms restrictions.

Thanks to Anna's work, our judges better understand the real-world experience of victims, what to expect from victims during cases, and their own power to address family violence in the courtroom.
