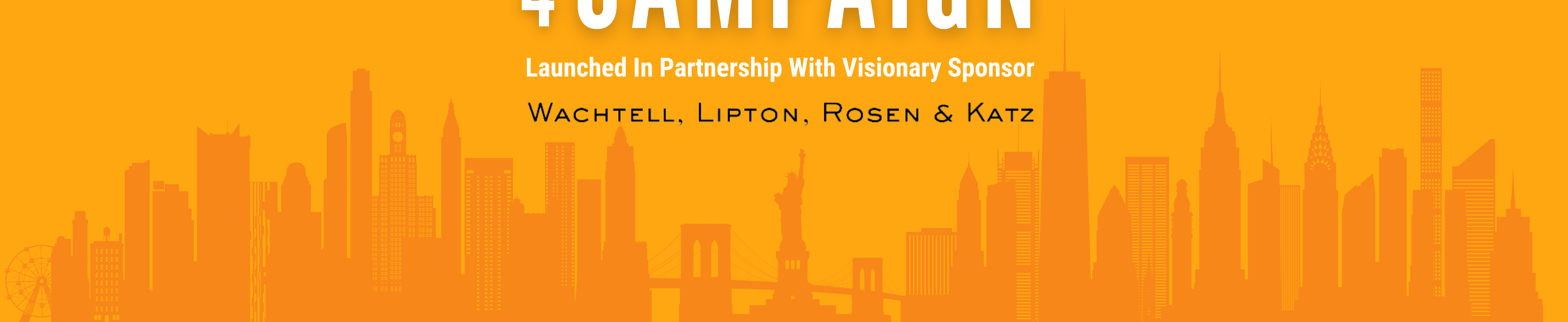

Without work authorization, 81% of our clients remained with their abusers **because their partner controlled household resources.**

Work authorization provides a way to escape abuse by **giving women the means to leave their abusers.**
