HER JUSTICE BREAKS RECORD FOR A FIFTH YEAR, RAISING \$3.4 MILLION TO DELIVER LEGAL HELP AND NEW BEGINNINGS TO WOMEN AND FAMILIES IN NEW YORK CITY

Her Justice Honors Alice Belisle Eaton, Esq. of Paul, Weiss, Rifkind, Wharton & Garrison and Steve Zelin of PJT Partners at its 2025 Annual Benefit

May 12, 2025, New York City – Her Justice, a nonprofit that provides free legal services in the areas of family, matrimonial, and immigration law to women in poverty and advocates for improvements to the civil justice system for all New Yorkers, convened industry leaders from across the city to honor Alice Belisle Eaton, Esq. of Paul, Weiss, Rifkind, Wharton & Garrison and Steve Zelin of PJT Partners at its Annual Benefit on Tuesday, May 6, 2025 at Pier Sixty, Chelsea Piers.

For the fifth year in a row, the event broke organization records, raising an historic \$3.4 million for Her Justice's work advocating for and with women seeking safety and autonomy through the civil justice system. Our community of supporters also celebrated Executive Director Alexia Korberg, who stepped into leadership at Her Justice this past fall after more than a decade at Paul, Weiss where they served as a Partner in the Litigation Department and developed a nationally-recognized constitutional impact litigation practice.

"Last year, we were tasked with the daunting responsibility of finding a new Executive Director who would build on our strong 30-year foundation and expand our work in new and exciting ways," said **Kelley Cornish, Chair of the Her Justice Board of Directors,** "Alexia is a true change-maker with a passionate commitment to use their many talents to do good in this world. Alexia, we are so lucky to have you leading us in this critical work during this time of immense disruption and intense need."
